4. First aid measures

4.1 Description of first aid measures

In case of doubt or when symptoms of feeling unwell persist, get medical attention. Never administer anything orally to persons who are unconscious.

Inhalation.

If wearing contact lenses, remove them. If breathing is irregular or stops, perform artificial respiration. Do not administer anything orally. If unconscious, place them in a suitable position and seek medical assistance.

4.2 Most important symptoms and effects, both acute and delayed

5. Firefighting measures

6. Accidental release measures

6.1. Personal precautions, protective equipment and emergency procedures

Eliminate possible ignition points and ventilate the area. Avoid breathing fumes. For exposure control and individual protection measures, see section 8.

6.2. Environmental precautions

Prevent the contamination of drains, surface or subterranean waters, and the ground.

6.3. Methods and material for containment and cleaning up

Pick up the spill with non-combustible absorbent materials (soil, sand, vermiculite, diatomite, etc.). Pour the product and the absorbent in an appropriate container. The contaminated area should be immediately cleaned with an appropriate decontaminator.

Pour the decontaminator on the remains in an opened container and let it act various days until no further reaction is produced.

7. Handling and storage

7.1. Precautions for safe handling

The fumes are heavier than air and can spread across the ground. They can form explosive mixtures with air. Prevent the creation of flammable or explosive fume concentrations in the air; prevent fume concentrations above work exposure limits. The product must only be used in areas where all unprotected flames and other ignition points have been eliminated. Electrical equipment has to be protected according to applicable standards. The product can be electrostatically charged: always use earth grounds when transferring the product. Operators must use antistatic footwear and clothing, and floors must be conductors.
